Flags to be Flown Half-Staff Tuesday for Serviceman Killed in Iraq

LANSING – Governor Jennifer M. Granholm today ordered that United States flags throughout the state of Michigan and on Michigan waters be lowered for one day on Tuesday, August 22, 2006, in honor of Army 1st Sergeant Aaron D. Jagger, of Hillsdale, who died August 9 while on active duty in Iraq. Flags should return to full-staff on Wednesday, August 23. Army 1st Sergeant Jagger, age 43, was killed when an improvised explosive device detonated near his HMMWV during combat operations in Ar Ramadi, Iraq. He was assigned to the Army's 1st Battalion, 37th Armor Regiment, 1st Armor Division, Friedberg, Germany. Under Section 7 of Chapter 1 of Title 4 of the United States Code, 4 USC 7, Governor Granholm, in December 2003, issued a proclamation requiring United States flags to be lowered to half-staff throughout the state of Michigan and on Michigan waters to honor Michigan servicemen and servicewomen killed in the line of duty. Procedures for flag lowering were detailed by Governor Granholm in Executive Order 2006-10. When flown at half-staff or half-mast, the United States flag should be hoisted first to the peak for an instant and then lowered to the half-staff or half-mast position. The flag should again be raised to the peak before it is lowered for the day. When a member of the armed services from Michigan is killed in action, the Governor will issue a press release with information about the individual(s) and the day that has been designated for flags to be lowered in his or her honor. The information will also be posted on Governor Granholm's website at www.michigan.gov/gov in the section titled 'Spotlight.'

Governor Corzine Orders Flags To Fly At Half-Staff To Honor U.S. Army Specialist Hai Ming Hsia

TRENTON – In honor of U.S. Army Specialist Hai Ming Hsia, Governor Jon S. Corzine signed the following Executive Order calling for the United States and New Jersey flags to fly at half-staff on Wednesday, August 23, 2006. The full text of the Executive Order is below. EXECUTIVE ORDER NO. 28 WHEREAS, United States Army Specialist Hai Ming Hsia was raised in New York City, and his wife currently lives in Newark, New Jersey; and WHEREAS, Specialist Hsia enlisted in the United States Army in 2002; and WHEREAS, Specialist Hsia proudly served in the United States Army; and WHEREAS, while serving with the Army's 6th Infantry Regiment, 1st Armored Division, in Baumholder, Germany, Specialist Hsia was deployed to Iraq in 2005 for a second tour of duty in that combat theater; and WHEREAS, Specialist Hsia gave his life in the line of duty during combat operations in Ramadi, Iraq; and WHEREAS, Specialist Hsia served his country with honor and distinction and has been recommended for some of our nation's highest military honors; and WHEREAS, Specialist Hsia was a committed soldier who loved his family, parents, wife, son, friends and neighbors who take great pride in his commitment, professionalism, and achievements; and WHEREAS, Specialist Hsia has made the ultimate sacrifice, giving his life in the line of duty while serving our country in Iraq; and WHEREAS, Specialist Hsia's patriotism and dedicated service to his country and to his fellow soldiers make him a hero and a true role model for all Americans; and WHEREAS, it is appropriate and fitting for the State of New Jersey to mark his passing, remember his family, including his wife who resides in New Jersey, and honor his memory; NOW, THEREFORE, I, JON S. CORZINE, Governor of the State of New Jersey, by virtue of the authority vested in me by the Constitution and by the Statutes of this State, do hereby ORDER and DIRECT: 1. The flag of the United States of America and the flag of New Jersey shall be flown at half-staff at all State departments, offices, agencies, and instrumentalities during appropriate hours on Wednesday, August 23, 2006, in recognition of the life and in mourning of the passing of United States Army Specialist Hai Ming Hsia. 2. This Order shall take effect immediately.

Governor Orders Flags Lowered for Palmer Soldier

(Juneau) ? Governor Frank H. Murkowski today ordered Alaska flags to be lowered to half staff in honor of Spc. Shane W. Woods, an Alaskan soldier who died on August 9 in Iraq. Spc. Woods and two other soldiers were killed when an improvised explosive device detonated near their vehicle in Ar Ramadi, Iraq, during combat operations. "We are deeply saddened by the death of Shane Woods, and express our condolences to his family and friends," Murkowski said. "It is a mark of his character that he dedicated himself to the fight for freedom for oppressed Iraqis, giving up the comforts of home to take on a difficult task. His selflessness and his commitment will long be remembered by Alaskans." Spc. Woods, 23, was from Palmer. All three soldiers were assigned to the Army's 1st Battalion, 37th Armor Regiment, 1st Armored Division, based in Friedberg, Germany. The governor ordered state flags to be flown at half staff from Tuesday morning, August 15, until Friday afternoon, August 18. Murkowski will send a letter of condolence and a state flag to the family of Spc. Woods. A service for Spc. Woods is scheduled for 11 a.m. on Friday, August 18 at the First Baptist Church in Palmer.
